Spray or Snip and Chip Your Cat From £5 – Cats Protection

Cats Protection recommends that cats are spayed or snipped at around 4 months of age or younger.

Microchipping offers cats a safe method of identification so should they go missing they are more likely to be reunited with their owner. If you live in the FK1 – FK21 post code areas and are on low income or benefits, you can get your cat done from just £5.

A New Kitchen Is A Dream Come True

One of our households at De Moray Court, Cornton, has received a Scottish Government grant to enable a fully adapted kitchen to be installed to meet the requirements of a wheelchair user.

The new kitchen includes a hob and sink that lowers on sensors and a cool drawer to put hot items on underneath the oven. Food is stored in metal baskets that can now be easily reached as they also lower within easy reach.

Chelsea said: “Before I could not do anything in the kitchen. Now I can make a meal. It has improved the quality of my life and given me more independence. It’s great not to have to wait until a Parent comes home to make a meal.”

As well as cooking meals Chelsea is now going to bake cakes to raise funds for her local tenants group De Moray Association. What a great way to use a new skill.



I Am Me - Keep Safe National Initiative

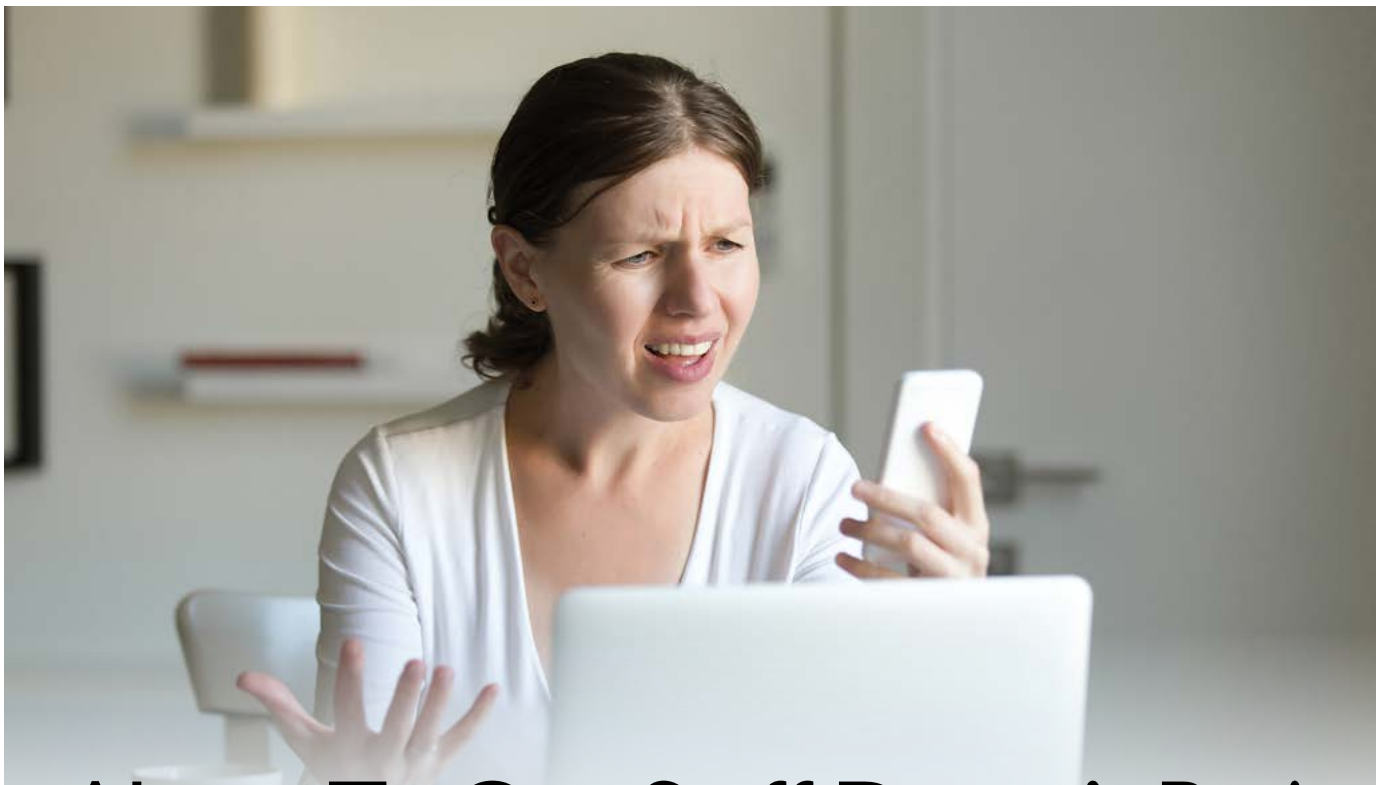


Forth is a safe place for those who might be vulnerable.

The Keep Safe project is a national initiative developed by the community based charity I Am Me, working in partnership with Police Scotland. The aim of the initiative is to establish a network of safe places for people who may be vulnerable. This might be due to a physical or learning disability, mental health issue, a sensory impairment, dementia or frailty. Our offices are somewhere where they can go when lost, distressed or frightened. Individuals utilising the scheme will carry a card with the contact details of the person they would like to be contacted if they are in need of assistance. The card may also include information

about the person's health and how they communicate.

As we have signed up to the project we display a sticker on the front window of our premises to indicate our participation. Our staff have all recently had training from Police Scotland. They will contact the person's support or in cases of criminality the Police, when presented with the Keep Safe card. A mobile app also allows users to plan routes, identify participating businesses, as well as contacting and reporting incidents to police. Abuse To Our Staff Doesn't Pay!

We can all get frustrated at times but it is important to remember that our staff have a job to do and we don't get paid to take abuse.

A former Forth tenant was recently taken to Court and was convicted of an offence under the Communications Act 2003. This followed a series of abusive phone calls to our office, during which, amongst other things, they threatened to stab a

staff member and put the whole street up on fire.

If anyone is dissatisfied with the conduct or work of a Forth staff member they have the right to legitimately complain, via our complaints process. However, they don't have the right to be offensive, rude or violent to staff. As this recent case shows criminal action will be pursued if this proves necessary.

Nextbike is the city's public bike share scheme to enable you to cycle around Stirling in an affordable and enjoyable way. There are 23 stations located around

Stirling, Bridge of Allan, and Bannockburn, where you can collect and return a bike. The Nextbike scheme provides convenient access to a bike without worries over the cost, storage, maintenance or theft of a personal bike.

For just £3, Forth Environment Link can provide the equivalent of a £60

annual membership to the scheme. This will give you access to over 150 bikes across Stirling. The bikes can be used for any kind of journey; to access everyday services; commuting to education, employment or work experience; or social journeys to visit friends and family.

Help From Start-up Stirling

Start-up Stirling, a local charity that helps homeless people, has 3 areas of focus:

- **Start up Foodbanks**
- **Helper Packs**
- **Start up Support**

People are referred for a number of different reasons but have one thing in common—they are in financial hardship and have no means to provide the basics for themselves or their family. They may be caught in the revolving door of poverty; they may have had benefit sanctions or delays imposed on them; they may have lost their job; their family may have broken down; even an unexpected bill can leave some in crisis.

There are 3 Foodbanks each week across Stirling in: Stirling City Centre, Hillpark and Raploch.



Each food pack contains the staples—dried and tinned foods—to feed an individual or family for 3–4 days. Start-up rely almost entirely on the local community to donate these items. We now have a Donation Station located in our office reception if you wish to donate dried or tinned foods.

Legionnaires' Disease is Uncommon But Can Be Serious – Reduce Your Risk!

Legionella is a lung infection you can catch by inhaling droplets of water. There are some simple steps to protect you in the home:

- 1/ You have to turn your shower on and run it for a few minutes at least weekly, preferably more often than this, to flush out stale water.
- 2/ On a weekly basis run water through all the taps.
- 3/ Descale your showerhead every 3 months or earlier if scaling is evident.
- 4/ If you have an electric hot water tank fully heat the water in it and then use the water immediately after, at least 2-3 times per week. Temperatures above 60 degrees will kill legionella bacteria so set the temperature of your boiler/cylinder to a minimum of 60 degrees. However, beware of scalding and take extra care if you have children.

Scottish Housing Regulator (SHR) Recruiting – Join The National Panel of Tenants and Service Users

Can you Claim The New Pregnancy and Baby Payment?

The new Scottish Government Pregnancy and Baby Payment will be available to apply for from 10 December 2018.

You could be eligible for a payment of £600 on the birth of a first child and £300 for each sibling born thereafter. To be qualify for the payment the family requires to be in receipt of any of the following benefits:- Income Support/Income-based Jobseekers Allowance/Income-related Employment and Support Allowance/Pension Credit/Universal Credit/ Housing Benefit/Child Tax Credit/Working Tax Credit

Applications can be made from the 24th week of pregnancy or up until the child is 6 months old.

If the expectant mother is under 18 or 18/19 years and still dependant on their parents and in full time education or training – they do not need to be in receipt of a qualifying benefit to be eligible.

Changes to your Scottish Secure Tenancy (SST) Rights

Introduced by the Housing (Scotland) Act 2014

The implementation of the Housing (Scotland) Act 2014 has introduced changes to your rights under your Scottish Secure Tenancy (SST) Agreement. In August 2018 we wrote to all our tenants confirming the changes. These changes will be implemented in 2 phases. This article summarises the main changes that will be implemented from May 2019, in the first phase.

1st May 2019

Ending a SST by Court Order:

The Act changes the way in which a SST can be ended following a conviction for serious anti-social or criminal behaviour. In certain circumstances a Court does not have to consider whether it is reasonable to make an order for eviction where the landlord has grounds for recovery of possession.

Adapted Properties:

The Act allows us to ask a sheriff to grant an order to end the tenancy of an adapted property that is not occupied by anyone who needs the adaptations. This only applies where the landlord requires the property for someone who does need the adaptations. In these circumstances we will offer you suitable alternative accommodation and you would have the right to challenge the decision.

Conversion to a Short Scottish Secure Tenancy or Antisocial Behaviour:

The 2014 Act extends the circumstances when we could serve notice on a tenant converting their SST to a Short Scottish Secure Tenancy. A Short Scottish Secure Tenancy has a fixed duration, unless we agree to extend it or convert it back to a SST.
